  - Change of Command Ceremony – This event is scheduled for January 27, 2011.
  - 2011 Budget – The Chief and Deputy have both been occupied with preparation of the budget and associated meetings at City Hall.
  - Kerr Building Fire – Emergency Social Services takes care of the victims of the individuals affected by the loss of the Kerr Apartment building. The Nelson Police regional Victim Services workers coordinated this assistance. The Chief indicated a business case could be made for ESS to be run out of the Nelson Police Victim Service Department.

**Discussion:** Deputy Chief Paivarinta fielded questions from the Board Directors with respect to the 2010 Year End Crime Stats.

**Financial Reports to December 31, 2010.**

**Discussion** – The Police Department will end the 2010 fiscal year \$150,000 under budget due to Department generated revenues from wages recovered from Olympic Secondments, Cell Block improvements recovered from the RCMP, and because Traffic Fine Share Revenues were up for the year.


